ECONOMICS DEPARTMENT NETAJI SUBHASH CHANDRA BOSE GOVT. GIRLS P G COLLEGE, ALIGANJ LUCKNOW, U.P. is a renowned and famous college for imparting knowledge education among the girls. It was named after the great Indian leader Netaji Subhash Chandra Bose who was a champion of women' rights. The foundation stone of the college was laid by sri Atal Bihari Bajpai on 14th April 1997. There are many private colleges in the city but this was the first Government college.

The present MOU records terms and conditions between the parties as follows:

1. Research:

Students of both parties will benefit from research activities by using science and technology laboratories, libraries, and appointing co-guides/ supervisors in research projects or other research work of different departments of both parties.

2. Exchange of faculties:

Students of both parties will be benefited by exchanging the teaching faculties of different subjects (which is required) without any financial involvement.

3. Cultural and extra-curricular activities:

The students of the First party will participate in different cultural and extracurricular activities of the second party to give broader exposure to the students, as the First party is a Dayanand Vedic College, Orai.

4.Participation/Collaboration of staff from both parties in different International and National seminars.

5. Use of Infrastructure:

Both parties will use the infrastructure of each other as needed and available on the prescribed terms and conditions. For the welfare of the students.

6. Terms and Conditions:

- ThisMOU shall be effective from the date it is signed by the parties and shall be vailed for five years extendable up to ten years. Both parties shall review the status of the MOU at the end of each five years to determine any modification. Whenever necessary. The period of vailidity of this MOU may be extended by mutual consent up to ten years. This MOU may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least six months in advance from the effective date of termination.
- All joint activities not completed at the expiration or termination of the MOU may be continued until their completion under the terms of this MOU.
- No amendment or modification of the MOU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same for amendment of the MOU. The modification changes shall become part of the MOU and shall be effective from the date on which they are made executed unless otherwise agreed.
- Financial terms and conditions will be decided mutually as per the needs of both parties.
 This MOU will be considered only for academic and R & D purposes only by both parties.
- 7. Amendment to the agreement: During the operation of the agreement, circumstances may arise which may call for alteration or modification of this agreement. These modifications/ alterations will be mutually discussed and agreed upon in writing.

8. Arbitration

The issues that are not addressed or stipulated in the MOU shall be discussed and resolved through negotiation in good faith and such resolution will be incorporated as written amendments to the MOU by mutual agreement between both parties.

No disputes are foreseen in the implementation of the MOU.the two parties, however, agree that if any dispute arises between them, efforts will be made to settle the same as amicably as possible. If the dispute remains unsettled, it will be referred for resolution bilaterally to the Economics department, Dayanand Vedic College, Orai, and preceptor, The ECONOMICS DEPARTMENT NETAJI SUBHASH CHANDRA BOSE GOVT. GIRLS P G COLLEGE, ALIGANJ LUCKNOW, U.P. the decisions so arrived at shall be final and binding on the parties to this MOU.

This MOU has been executed in two originals, one of which has been retained by the First party and the other by the Second party.
